### HIGHWAY SUPERINTENDENT REPORT

Sign and mailbox repairs completed, prepared and responded to flooding conditions from snow melt and heavy rains.

#### ASSESSOR'S REPORT

The assessor reported that change notices will be mailed out in the next few weeks. He is not sure if these increases will be enough to get the State to certify the roll ay 100% in June. He submitted a chart of the numbers for the last three years on a few categories. The biggest decrease is in the utility values which are done by the State and not the Town. The 2022 numbers are tentative as all exemption calculations are not run yet until tentative roll.
