The process going forward for this application is to submit the application to the County Planning Board following the Zoning Board meeting next Monday by the 19<sup>th</sup> for their meeting on the 26<sup>th</sup> of October. A joint public hearing of this board and the zoning board will be on November 13<sup>th</sup>.

Mr. Depatie asked about the comprehensive planning committee. He had received an email with four different dates to which he responded and has not heard anything since. Mrs. O'Toole stated that as of Friday, two have not responded. Also, supposedly a situation that will be discussed at the town board meeting. It was questioned on the process when it has been completed by LaBella. Mrs. O'Toole stated

that the planning board will review it and made a recommendation to the town board who will hold the public hearing.

Water District 10 asked about. Some comments made were:

- Been awful dry and wells are going dry
- The water is bad and sometimes not enough to do what is needed
- Thought district may not make it but hopes that it does
- It is expensive, especially for those considered poverty level

It was mentioned that the AES Baird Solar farm is putting up hedges. Mr. Keeler stated he was contacted with the existing grades were not represented correctly and a retention pond was required and is eliminated from the site plan. The DEC has jurisdiction on this. Mrs. O'Toole has been working with the applicant and town which the cost will come out of the escrow account.
