CALL TO ORDER: The board met at the Town Hall with the meeting called to order at 7:00 pm by chair Mr. Coville.

I. <u>APPROVAL OF MEETING MINUTES – August 21, 2023</u>

Mr. Gaylard made a motion to approve the meeting minutes of August 21st meeting with one spelling error and seconded by Mr. Swan and carried (5-0).

II. <u>NEW BUSINESS</u>

Mr. Coville asked Mr. Burgdorf to present the application of Bell Atlantic/Verizon application. He stated that Verizon is a public utility with inadequate coverage in this area. The tower can not be too high or too low because of interferences. Mr. Burgdorf pointed out section G - 16 with the existing coverage and G - 17 of what would be the coverage with the new tower. Section H with the large red circle was the targeted area for the new tower. We will co-locate, if possible, on tall buildings, silos, church steeples. However, that is not possible in this area. Therefore, we contacted landowners that were not in wetlands. There were 16 sites identified with the outcome being the Daniels residence. The tower will be 174 feet tall with attached lighting rod, a 100x100 equipment base, not lighted and surrounded by a chain link fence. FAA approval is needed as well; therefore, it would be a conditional approval until they approve the tower which Verizon expects it to be. Private air strips are exempt from consideration. A height variance is needed from the zoning board. The planning board has also reviewed the application for a special use permit and site plan review. Discussion took place:

- Drop zone was asked about. The tower is rated for 100 mph winds which are extremely rare in this area. The fall zone would be half the height of the tower and there is plenty of room around the tower.
- MRB Group has been hired by the town as the engineer for the project
- The planning board declared itself the lead agency for the SEQR review and is an unlisted action

- Other towers have multiple different "chains" securing the tower, will this tower also? This tower is a lattice tower and will not have chains.
- There used to be good cell reception in the western part of the town and now there is not because of the signal bouncing around. This tower should eliminate this
- What about TV and radio interference? If it happens, someone is on a wrong frequency and needs to be corrected by federal law
- The engineer's report is hopefully going to be completed by late September. With that completed, the boards should be able to submit the application to the County Planning Board at October's meeting. This would allow a combined public hearing to be scheduled for November 13th. The date was agreeable to the zoning board as it is not a normal meeting date for them

Mr. Coville asked for volunteers to representative the zoning board on the Comprehensive Plan review committee. After a moment, Mrs. Dudley said she would volunteer. Mr. Gaylard volunteered to be the alternate representative.

A brief discussion was had with Mr. Leddon for the alternate position.
