RESOLUTION #45 Water District #10/SEQR Negative Declaration

AMENDED NEGATIVE DECLARATION OF ENVIRONMENTAL SIGNFICANCE FOR TOWN OF BARRE WATER DISTRICT 10

At the meeting of the Town of Barre Town Board held on July 10, 2024, Councilman Kirk Mathes moved adoption of the following resolution: Councilman Margaret Swan seconded the motion and was passed. WHEREAS, in 2018, the Town Board of the Town of Barre (hereinafter the "Town Board") applied for funding assistance from USDA Rural Development for the creation of a proposed water service area (also known as "Water District #10" or the "Project"). The proposed Project involved the installation of approximately 23,350 linear feet of 8-inch waterline along portions of Angevine Road, McNamar Road, and Transit Road. Proposed activities also included the installation of the watermain, a master meter pit, fire hydrants, valves, watermain connections, residential hook-ups, road crossings, excavation and bedding materials and surface restoration; and WHEREAS, the Town Board initiated a SEQRA review for the Project. On or about August 8, 2018, the Town Board classified the Project as a Type I Action under SEQRA and declared its intent to serve as Lead Agency; and WHEREAS, the Town Board notified the involved agencies of its intent to serve as Lead Agency for the Project and no objections were received; and WHEREAS, on or about October 10, 2018, the Town Board declared itself as Lead Agency and based on its review of the Full Environmental Assessment Form Parts 1, 2, and 3 and supporting Project documents, the Town Board determined that the Project would not result in any significant adverse environmental impacts and issued a Negative Declaration for the Project; and WHEREAS, the proposed Project did not move forward after the 2018 Negative Declaration was issued, and the Project was not constructed; and WHEREAS, the Town of Barre now desires to proceed with the proposed Project and is applying for 2024 NYS Community Development Block Grant (CDBG) program funds for the Project. The 2024 Project scope remains unchanged from the original 2018 Project scope; and WHEREAS, the Project's SEQRA findings has been updated to reflect new information and results of 2024 agency consultations regarding potential environmental impacts as described in the findings narrative attached to this resolution; and WHEREAS, after analyzing the 2024 SEQRA findings narrative for this Project and the previous 2018 environmental review record (including Parts 1,2, and 3 of the 2018 Environmental Assessment Form), the Town Board seeks to issue an amended Negative Declaration in compliance with 6 NYCRR §617.7 (e) (1) (ii). NOW THEREFORE BE IT RESOLVED, 1. The Town Board, as lead agency, hereby accepts the 2024 SEQRA findings narrative. 2. The Town Board has thoroughly reviewed the Environmental Record prepared for this Project, including the original SEQRA record prepared for this project in 2018 (including the 2018 Environmental Assessment Form Parts 1, 2, and 3) and the 2024 SEQRA findings narrative. 3. The Town Board has considered significance of any potential environmental impacts according to the criteria set forth in 6 NYCRR § 617.7(c); and has thoroughly analyzed the identified areas of relevant environmental concern. 4. Based on its review of the Project's entire environmental record, including the 2024 SEQRA findings narrative, the Town Board has determined that the Project would not result in any significant adverse impacts. The Town Board, therefore, issues an amended Negative Declaration pursuant to 6 N.Y.C.R.R. § 617.7 (e)(1)(ii). 5. The question of the adoption of the foregoing Resolution was duly put to a vote on roll call, which resulted as follows: 5 yes, 0 no. Passed

RESOLUTION #46 Water District #10/ Certifying Officer

NYS CDBG APPLICATION FOR WATER DISTRICT 10 DESIGNATION OF CERTIFYING OFFICER AND ADOPTION OF ENVIRONMENTAL REVIEW RECORD

At the meeting of the Town of Barre Town Board held on July 10, 2024, Councilman George McKenna moved adoption of the following resolution: Councilman David Waters seconded the motion and was passed. WHEREAS the Town of Barre is applying to the New York State Office of Community Renewal for Community Development Block Grant (CDBG) funds for the creation of a water service area (also known as "Water District #10" or the "Project") which involves the installation of approximately 23,350 linear feet of 8-inch waterline along portions of Angevine Road, McNamar Road, and Transit Road. Activities also include the installation of the watermain, a master meter pit, fire hydrants, valves, watermain connections, residential hook-ups, road crossings, excavation and bedding materials and surface restoration. The purpose of the Project is to improve the Town's water quality and access to public water resources; and WHEREAS, LaBella Associates, DPC has prepared an Environmental Review Record for this Project meeting the requirements set forth in 24 CFR 58.38, including an Environmental Assessment. NOW BE IT THEREFORE RESOLVED, that the Town Board hereby adopts the Environmental Review Record for this Project; and RESOLVED, that the Town Board designates Sean Poque, Town of Barre Supervisor, as the Certifying Officer, responsible for all activities associated with the environmental review process for this Project. Vote 5-0, passed.

RESOLUTION #47 Water District #10/Purchase/Water line Materials George McKenna made a motion to approve the purchase of water line material for Water District #10, the motion was seconded by David Waters. Vote 5-0, passed.

RESOLUTION #48 Property Clean Up/Allis Road Supervisor Pogue made a motion to direct the Barre Highway to clean up the property at 13455 Allis Road and assess the cost onto the property owner's property tax bill unless the property is sold at the Orleans County tax foreclosure auction. The motion was seconded by Kirk Mathes. Vote 5-0, passed.

Attorney Report - Bridget reported that the bids for the county ambulance service will be opened in the Town of Gaines on July 22nd. She also reported that she is working on the issue with Family Energy who alleges that we switched to their company for our energy provider.

<u>Comprehensive Masterplan</u> - The next meeting is scheduled for July 29th at 7PM.

<u>Planning Board</u> - Councilman Mathes reported: 1.) that DRW of Crown Castle received permission for a modification to their Special Use Permit. 2.) McKey Brothers' Site Plan Review was approved with some special conditions. (property on Hemlock Ridge Road)

Zoning Board - Councilwoman Swan reported that the next meeting will be on July 15, 2024 at 7:00pm.

Park Committee - Playground will soon be up and running. Donations are coming in to improve the park. Power is almost ready to turn on. Walking trails will be discussed at the next meeting. It has been suggested that the Town hold a ribbon cutting celebration with recognition to groups and individuals who have contributed to the park fund and people who made donations.

Utilities - No Report

Orleans County Representative - Mr. Eick reported on the progress with moving the county departments around to the new sites, and the STAMP project, Orleans County has spent \$93,000.00 to date to stop the project.

Margaret Swan made a motion to adjourn the Town Board meeting, seconded by David Waters. Vote 5-0, passed.
