Draft Comprehensive Plan review: The board went through the plan page by page making comments.

- 1-1: The Town Board directed the Planning Board; the planning board basically had direction to start the project and had a say in who to pick the agency leading the project in the beginning
- 2-1: 3rd paragraph under Agricultural District Program was questioned and should be investigated more as we do not want to be restricted down the road with every project
- 2-2: Under Zoning code-do not just list a few, all should be listed, mining should be listed, we do not have R-1 District as of 12/29/2020
- 2-4: Spacing in g should be fixed
- 2-6: No mention of Parks or Recreation, look and compare to current comp plan
- 3-4: Zip code map at least for Medina is totally wrong
- 3-5 Table is correct about mining acres after reviewing again. The referenced map is based on land used by tax parcel and is correct as shown in reference to mining.
- 3-6: Map should be updated to reflect page 3-5; purple areas not all there
- 3-22: It is hard to believe that there are 16 houses in the town worth over \$1,000,000.00 or more and 113 in the county
- 3-23: Are the figures possibly wrong for females 16 years and over in labor force and employed?
- 3-26: Major Industries and Employment Centers #1 3rd paragraph second line are should be our
- 3-26: Major Industries and Employment Centers #3 the projects are approved not proposed. The whole paragraph is confusing with the use of both words proposed and approved being used
- 3-28: Is the 100 fee of transmission voltage line the correct length?
- 3-33: #3 Cable/Broadband RTO/Ambient has broadband capabilities on the water tower behind the fire hall and on the cell tower on Hemlock Ridge Road
- 3-34: #5 Electricity The wording does not include 3-phase electric down Maple Street for ¹/₂ mile. It does however show it on the map
- 3-35: Key does not list Water District 8 & 9, brown not on the key

- 3-37: What about the electric to the park and any future expansion. Under # 2 What about naming the organization involved with the snowmobile trails. What about the 4-Wheeler Club?
- 3-38: Spelling first line should be residents of not al Barre.
- 3-41: #7: Religious Facilities West Barre United Methodist Church is no longer United Methodist Church and is just West Barre Church as it disaffiliated from the United Methodist Church.
- 3-42: Color code the voting map i3-4nto the 2 districts making it easier to see
- 3-43 is a blank page
- 4-2: Survey Results and Public Comments first paragraph second to last line word all should be allow
- 4-2: Renewable Energy Second paragraph second line: end second line after 600 feet tall and eliminate will be visible from virtually everywhere in the Town. General comments: opinions being given and not just in this section there are a lot more. All for full disclosure but why definitely on green energy sections. Not addressed is what is/could be gained not opinions. Anything opinion based should not be included in the plan.
- 4-3: Paragraph about Clear Skies should be eliminated as well as the paragraph about the Hemlock Ridge solar project as anything referencing revenue for landoweners should not be included
- 5-1: In the 4th paragraph it is Manufactured Home not mobile home park now must be more that 900 sq feet by our current zoning
- 5-1: Planned Industrial/Commercial spacing in title, and in the second paragraph promote it rather than have it be constraints
- 5-3: Sewer System Improvements should include of the business district Down Rt. 98 to Root Rd. and 31A to Eagle Harbor Rd.
- 5-4: Should be same as current one
- 5-4: Bubble around airport is not large enough
- 6-3: Policy B 1 Short-term explained in key so it is not needed here
- 6-4: Policy B 3 Short-term explained in key so it is not needed here
- 6-4: Policy D 1 Short-term explained in key so it is not needed here
- 6-5: Policy A 1 Short-term explained in key so it is not needed here
- 6-5: Policy A 2 Short-term explained in key so it is not needed here
- 6-5: Policy A 4 What is meant here without permits?
